

CUSTOMER ROUTING INSTRUCTIONS 2010 V6

Shipping Terms, Bill of Lading

- Describe the shipment as "AUTO PARTS, NOI FAK, CL50".
- When SMP is responsible for freight charges, shipments to an SMP facility must be shipped "collect" via the carrier listed on the attached matrix.
- Shipments sent at our customer's expense are to be sent "prepaid" or our customer may ship "collect" via an SMP preferred carrier, and we will charge back the freight charges at our discounted rates.

UPS Shipments

• Shipments weighing 200 Lbs and less.

LTL Freight Shipments

- Shipments weighing less than 19,000 lbs but more than 200 pounds.
- Shipments less than 11 pallets. A pallet is defined as the floor space of a 40" X 48" pallet.
- Use the matrix to determine the carrier. <u>If the carrier listed does not serve the pickup city</u> call the contact person listed below for an alternate carrier.

Volume or Truck Load Shipments

The following types of shipments require special routing, call the appropriate Standard Motor Products Traffic Contact listed below for disposition.

- Full truckload shipments
- Shipments weighing 19,000 pounds and over.
- Shipments exceeding 10 pallets. A pallet is defined as the floor space of a 40" X 48" pallet.
